

2026 Bridgetown Invitation Tournament I-5 Showdown - Karyn Turner Memorial

Tournament Rules

This is a fundraiser for the non-profit Bridgetown Invitational Tournament (BIT), and The Karyn Turner Memorial Fund for TNBA. The tournament is a mixed, adult-only (18+) competitive bowling tournament open by invitation only.

This tournament has expanded to include all states along the I-5 corridor, with state bragging rights to include names on the new I-5 trophy, as well as individual awards. This is a fun gathering with a competitive format. We will be utilizing the full house at Triangle Bowl, with a breakdown pair gives 30 lanes.

Any questions please contact the tournament director at bittournamentdirector@gmail.com. Teams are made up of four bowlers. All four bowlers' payments for a team are required to be assigned a team number and claim a team spot. It is the captain's responsibility to manage a team's complete registration and payment.

Tournament date is: Saturday August 1, 2026

Check in begins at 9:00 AM – 10 minutes of practice will begin at 10:00 AM – There will be no additional practice between games. A pattern will be announced the week before.

Tournament Location: Triangle Bowl, Longview, Washington.

Tournament Cost is \$100.00 per person. Full team payment of \$400 is required to secure a team's place in the tournament. Once an entry has been entered and payment processed *no refunds* will be processed. (team captain can pay full team total \$400 when registering).

Tournament Play is 5 games, moving over 5 pairs of lanes for match play. Semi Finals are top four teams bowling 1 game, (1 bowls 3 and 2 bowls 4), followed by top 2 teams rolling off 1 game for the Tournament Championship!

Showdown is limited to 30 teams.

Payout: Top four teams will cash (based on 30 team entries.)

- First Place Team: \$2,000 (\$500 per bowler)
- Second Place Team: \$1,000 (\$250 per bowler)
- Third Place Team: \$800 (\$200 per bowler)
- 4th Place Team: \$400 (\$100 per bowler)

Scoring:

Total Standings are based on handicap scores per team for the five qualifying games and will be used to identify the top four teams for match play by total pins.

Total Standings Tie-Break(s):

If at the end of all regular bowling there is a total pin tie for any of the cashing positions (first, second, third or fourth) the following will apply:

There will be a single frame roll-off (all 4 bowlers will participate in any order) between the tying teams in cashing positions.

World Bowling Tour Single-Frame Scoring will apply for the roll-off (see scoring rules below). Scratch total of the roll-off will determine order of the higher ranking cash position.

Current frame scoring awards:
30 pins for a strike,
10 pins for a spare plus the pinfall of the first shot in the frame,
Actual pinfall after two shots in an open frame.

Bowler Order:

Teams may set/alter their lineup prior to the beginning of all bowling. Once practice has ended, no lineup changes are allowed. All games bowled with the same lineup.

Substitutions:

Substitutes will only be accepted until 10:00 PM, Pacific Time, July 24, 2026. No substitutes will be allowed the day of bowling, except in the case of extreme emergencies or bowler injury. Substitutes will only be allowed in these cases upon approval of the I-5 Tournament Director and the Bridgetown Invitational Tournament Board of Directors.

Lane Assignment:

Team numbers will be assigned by the tournament director in the order fully paid entries are received. Lane assignments will be assigned by Team Number.

Averages, Handicap, and Verification

Individual handicap will be 100% of the difference between the highest bowlers entering average. There is **NO team CAP**.

Averages will be verified in the following order:

- USBC composite league average from 2025-26 season (Fall/Winter). MUST be verifiable on Bowl.com. (No sport or challenge league averages will be accepted.)
- If no 2025-2026 current average the USBC composite league average from 2024-2025 will be used (Fall/Winter/Summer).
- All others will enter at an average determined by the tournament director per USBC Rule 319b.

There is no max team handicap and no individual negative handicap will apply. Bowlers who do not have a verifiable average will enter with 0 handicap at scratch.

In accordance with IGBO DEI, the Women's competition category for this tournament is open to transgender females holding a government issued female ID.

Code of Conduct for all participating bowlers, partners, volunteers and supporters:

- Be respectful and courteous to all people (bowlers, spectators, house personnel)
- Always display good sportsmanship
- Do not engage in any behavior which is threatening to others, verbal abuse, physical abuse, threats, anger, or inappropriate language. **Anyone displaying this behavior, either on the premises or on social media, can be disqualified from participation in the tournament and escorted from the premises.**
- All bowlers have an invitation unless they are notified of it being pulled.
- Score corrections may only be made by the house or by a member of the BIT committee.

Dress Attire:

- Bowling attire appreciated but not required; common sense shall rule.
- NO earbuds/headphones permitted on lanes while bowling.
- No hats indoors.
- Tournament director will have final decision on attire.

The tournament committee may make provisions for a bowler to "participate" ("participants") versus "compete" in the tournament. "Participating" removes that bowler's scores from competition and the bowler is ineligible to win prizes, awards, or funds for any and all events, brackets, and/or side pot games. "Participants" pay full entry.

Tournament Director has supervisory control of all parts of the tournament operation. The decision of the tournament director shall be final.
